

#### **Section Three: Composition**

The constituents of this product are being withheld under the provisions of 29 CFR §1910.1200(i). A full disclosure SDS is available to industrial hygienists, physicians and treating nurses.

This product may contain minor amounts of silica; the OSHA PEL for respirable quartz in this product is 3.4 mg/m3 of total product. The PEL for total quartz in this product is 10 mg/m3 of total product.

According to the best information available to ACT, Inc., controlling total nuisance dust exposures to 5.0 mg/m3 of total product will control exposure to the occupational limits for silica.

#### **Section Four: First Aid**

<u>Inhalation Exposure:</u> Remove the person to fresh air. Based on the estimated free-silica content, if respirable factions (as determined by NIOSH 0600 or equivalent) are maintained below 3.4 mg/m3, then free silica concentrations will be maintained below the PEL. Based on the estimated free-silica content, if total nuisance dust (as determined by NIOSH 0500 or equivalent) is maintained below 10.3 mg/m3, then free silica concentrations will be maintained below the PEL.

Note to physician: for clinically sensitized persons, respiratory distress due to an anaphylactic reaction to plant fibers, similar to byssinosis, and or (to a lesser extent) subtilisin exposures may occur.

<u>Eye Contact:</u> Minor injury to the eyes may result if the powder is placed directly into the eyes. Normal use as directed is not expected to result in eye contact. <u>Ventilation:</u> Standard industrial hygiene ventilation practices should be used to control human exposures to this product.

#### Personal Protective Equipment:

<u>Clothing:</u> Standard work clothing will provide adequate protection. The clothing should be removed at the end of the work shift and maintained at the work site.

<u>Gloves:</u> Standard nitrile, latex or leather gloves will provide adequate protection. (Gloves are not needed to use the product when used as directed).

# **Section Ten: Stability**

Stability: Material is stable. Spontaneous polymerization or reactions will not occur.

#### **Section Eleven: Toxicological Information**

Note 1: The PEL for respirable quartz in this product is 3.4 mg/m3 of total product. The PEL for total quartz in this product is 10.3 mg/m3 of total product. That is, if the total dust is below 10. mg/m3 AND the respirable faction is less than 3.4 mg/m3, none of the components of the product will be present in concentrations greater than the OSHA PEL. The product has not been evaluated for the presence of other silica morphs such as tripoli, tridymite, and cristobalite.

Note 2: According to the best information available to ACT, controlling exposures to 5 mg/m3 of total product will guarantee exposure control to all occupational limits of the material at the upper confidence limit. Persons with cotton or corn hypersensitivity or cross-sensitivities should avoid contact with the dust. <u>General Discussion:</u> The primary adverse health concerns with the product are due to incidental silica content. Smokers who use our product will be at a greater risk of contracting adverse health problems.

<u>Notes to Industrial Hygienist and Physician:</u> ACT, Inc. recommends that exposures to people with TB, silicotics and others with interstitial lung diseases or fibrosis of the lung should be controlled to a conservative level.

<u>Acute Health Effects:</u> Ingestion may cause gentle CO2 gas production in the stomach. Anaphylactic (allergic) reaction may occur in people sensitive to cotton-like dusts.

<u>Chronic Health Effects:</u> Although not expected when used as directed, abuse and careless application may result in silicosis or silicotic-like lung changes.

<u>Cancer Hazard:</u> Various morphs of silica have different carcinogenic ratings. This product is considered to contain a carcinogen due to the silica content.

### **Section Twelve: Ecological Data**

Ecological data were determined from an ACT product that represents the worst case scenario. Those tests indicated an ecologically safe product. This product would be even less toxic than the model
